

A Guide to Continued Registration for Pharmacists and Pharmaceutical Assistants



Version 1 September 2021

Introduction

This guide outlines the steps involved in completing Continued Registration as a Pharmacist or Pharmaceutical Assistant in the PSI Registration Portal. Registrants wishing to remain on the register to practice in Ireland must apply online on an annual basis for Continued Registration and pay an annual fee.

Process

• **Step 1:** You will receive a reminder about your Continued Registration by email and as a notification in the Registration Portal 60 days before your registration certificate expires.

Continued Registration reminders are sent based on your registration expiry date.

Step 2: You can log into your profile in the PSI portal by clicking on the link in the email. You will need your email address and password, along with the phone you used to set up your account. A unique code will be sent to your phone as a text message each time you log into the portal as part of the system security checks. Once you log in, navigate to Pharmacists > Continued Registration and click on Create to start your application for Continued Registration.

 Step 5: Submit the application by completing payment for your Continued Registration by credit or debit card. Following payment, you will receive an email and notification in the Registration Portal confirming that your application has been received by the PSI.

 Step 6: Following review of the application by PSI, you will receive a confirmation email and portal notification approving your application and confirming your registration for a further 12 months.

It may be necessary in some circumstances for the PSI to request further information from you at this stage before your registration can be confirmed.

 Step 7: Once your Continued Registration has been confirmed, a digital Registration Certificate will be made available immediately in the portal (My Registration > Registration Certificates). The official Registration Certificate will be printed and posted to the address in your profile. Your name will also continue to appear on the public Register which is searchable on the PSI website.
